PLAYER POINTS INDEX SYSTEM (PPIS)

CONDITIONS RELATING TO CATEGORIES

INDEXING

- 1. A Player will have only their playing history for past 5 Seasons from the time of registration with a club considered for categorisation purposes (unless they have not played in the last 5 seasons or their continuity in the game has been disrupted by Covid cancelled competitions (*Registered with club prior to competition cancellation).
- A Player will be categorised at the highest level they have played in those 5 seasons.
- 3. A Player must play not less than five (5) competition matches (in any one season) at any level to be correspondingly categorised at that level.
- 4. For the purposes of categorisation, a Player need only take the field in a competition match for such to count as having played the whole competition match.
- 5. For any Player to receive the points reduction available in the second and third seasons, such Player must have been registered and played with the Club in consecutive seasons unless there has been a season between where the player did not play.
- 6. Players registering in consecutive seasons with a single Club will be reduced in value at the rate applied to the Category and points they were determined when registering with such Club for the first time and progressively reducing to zero.
- 7. A Player shall be entitled to a single point reduction to a maximum of 5 points for every season since playing at their highest level in which they have not been registered or has not otherwise taken the field in a competition match.
- 8. An Internal Transfer Player participating in a second-tier team may be indexed at 15 points in that grade and 25 points in the first-tier level for player movement between those grades where the second tier team's total quota is half or less of that which the first tier team has.
- 9. A Player shall be entitled to a 25% point reduction of their quota for every year playing after the age of 33. That reduction can be no greater than 5 points overall regardless of the number of years in which they're eligible to apply. (see FAQ examples)
- 10. Notwithstanding anything contained herein, a Club Junior shall be assessed as zero points for indexing purposes.

ONUS ON CLUB TO MANAGE PPIS

- 1. Each participating club shall attribute a point's value to each player and submit same at the time of registration of such player. It is the responsibility of the club and player to ensure that the assessment sheet is properly completed and signed.
- 2. Not less than 7 days prior to Round 1 of Season 2025, and prior to each Round and Finals series match thereafter clubs shall provide Newcastle RL with documentation verifying the PPIS value of each individual player registered in their club at that time.
- 3. Each player whose name appears on any official match sheet for 1st Grade, 2nd Grade, Open Age or 19s competition must have their individual points allocation recorded where indicated in such match sheet.
- · 4. The subject team must have their total points allocation recorded where indicated in the relevant match sheet.
- S. Any enquiry by any Club regarding the points allocated to a Player from their Club or another Club must be in writing addressed to the Newcastle Competition Secretary
 and marked Attention: Competition Committee.
- 6. Any protest by a Club regarding an opposition team exceeding their points allocation in a particular match must be in writing addressed to the League's Secretary and marked Attention: Competition Committee and submitted prior to 5.00pm on the Wednesday immediately following the subject match.
- 7. Following grading by the local League any application for a reassessment of points must be in writing and addressed to the NSWRL Zone Manager and marked Attention: PPIS Appeals Committee.
- 8. Any Club determined by the Competition Committee to have exceeded their total point's allocation for any given match shall automatically lose all competition points received from such match (which shall then be allocated to the opposition team) and be liable to pay a fine not greater than \$500 per point exceeded.
- 9. Any Club determined by the Competition Committee to have exceeded their total points allocation for any given match shall automatically have all points scored by its team in such match deducted from such team's total points otherwise scored to date.
- 10. Any Club determined by the Competition Committee to have exceeded their total points allocation for any given match shall automatically have all Club Championship points received for such match deducted from its total club championship points otherwise received to date.
- 11. Any player receiving Best & Fairest points in a team determined by the Competition Committee to have exceeded their points allocation for the match in which they received those Best & Fairest points, shall automatically have the Best & Fairest points so received deducted from their season total to date.
- 12. Any points scored by a player for a team determined by the Competition Committee to have exceeded their point's allocation for any given match shall automatically have such points deducted from their total points otherwise scored to date.
- 13. Any Hearings required as a result of alleged false or misleading information will be deemed a Code of Conduct Breach and be presided over by a panel nominated by the Association/League.
- 14. Clubs and/or Players found guilty by the Code of Conduct Panel of deliberately providing false or misleading information regarding points indexing shall each be liable to pay a fine of not less than \$500.

CLUB JUNIOR DEFINITION

- Any Player who is registered in their most seasons of junior international level rugby league with the subject Club.
- 2. Any Player who is registered in an equivalent number of seasons of junior international level rugby league with the subject Club and any other club but is registered for their first season of senior rugby league with the subject Club.
- 3. Any Player who is registered in an equivalent number of seasons of junior international level rugby league with the subject club and any other club within the same competition and is yet to register for their first season of senior rugby league may be considered local with either Club.
- 4. Any Player who is registered in the most seasons of junior international level rugby league with a club that does not have a senior club participating in that competition will be allocated as per the affiliate club pathways determined by Newcastle League and NSWRL.
- 5. Any Player who has played with multiple junior clubs may qualify for local status with the club where the majority of their playing history resides prior to and including their international age years.

EFFECT OF PLAYER MOVEMENT ON INDEXING AND INTERNAL TRANSFERS

We draw your attention back to the function of the PPIS as a grassroots system that ensures the sustainability of clubs in competitions while encouraging the promotion of their players along the many pathways which our game provides at all player levels.

Should a player leave their local club to improve their opportunity to play at a higher level in a NRL, NSWRL, QRL or Super League competition with an affiliated pathways club within those competitions they will not forgo their local status upon return to that club unless they have spent 3 or more seasons playing outside those affiliated pathways competitions.

Additionally, players who participate in such competitions as mentioned or RFL Championship, France Elite 1 or Betfred League 1 that allow a player to participate in two Leagues in the same calendar year will be treated in the same manner. This enables players the opportunity to move within competitions without losing their consecutive history and any deductions that might apply to an internal transfer quota when returning.

The League's Competitions Committee has the right to determine pathways affiliations by virtue of a known agreement between a pathways club and NRL or Super League club, by virtue of a player's contract with that club and by virtue of the opportunity to progress to a higher level of competition than that provided in his departing League.

The context of the policy is to allow Players registering in consecutive seasons with multiple Clubs to be reduced in value at the rate applied to the Category and points that were determined when registering with such Club for the first time and progressively reducing to zero. Players may not register for a short period in alternative competitions and then reregister at a new lower level with another club in the same competition which they departed. (see FAQ examples)

SCALE

A sliding scale points system will apply to the competition with the maximum team quota as declared by NSWRL's approved competition maximum. The points allocated to each team will depend on the position they finished after the premiership rounds are completed in the previous season.

Ladder Position

- Scaled reduction in points to team allocations for top 4 or 5 finish in previous season according to that competition's finals qualification's structure. Please note top 4 quotas reduce from 80% and top 5 from 75%.
- Full points to team allocation if finished in bottom half of competition and not relegated to a lower tier.
- Additional points to team allocation if team has been promoted to a higher tier from previous season.
- Same scaling applies to ladder position for teams in tier 2 and tier 3 (lower grade) competitions facilitated in Community Rugby League i.e Reserve grade minor premiers scaled down to 75% of 50 points = 37

INDEXING BASE	A Player will have only their playing history for five (5) seasons considered for categorisation purposes (unless they have not played in the last five (5) seasons or their continuity in the game has been disrupted by Covid cancelled competitions (*Registered with club prior to competition cancellation). A Player will be categorised at the highest level they have played in the five (5) years previous to the season of registration with a club and that amount will diminish in line with that grading while the player remains with that club. A Player must play not less than five (5) competition matches (in any one season) at any level to be correspondingly categorised at that level.
